APU will offer a 15% tuition discount for eligible law enforcement employees (and their spouse) who are currently enrolled in APU's Professional Criminal Justice or Psychology programs in the School of Behavioral and Applied Sciences. In order to apply the discount to your account, please fill out the following information and submit proof of employment.

Discount Information:

- The 15% discount applies to sworn officers, civilian employees and paid support staff from all federal, state, city, county, tribal and school law enforcement organizations. It does not include auxiliary, reserve, or volunteers.
- Spouses of law enforcement employees are also eligible for this discount.
- To receive this discount, students must submit valid, law enforcement identification. All IDs must reference specific law enforcement agencies; government-only IDs will not be accepted.
- This tuition discount is subject to coordination with Federal, State, and institutional regulations, which may result in a reduction of other aid in a student's financial aid package.
- This discount will be applied to the student account after the add/drop date of each term.
- <u>Please attach employment and law enforcement verification</u> (e.g. employee badge, letter from HR, etc.). Your discount will not be posted to your account until verification is received. Proof will be required at initial enrollment and every year thereafter. APU reserves the right to request employment verification at any time.

Discount Disclaimers:

- This tuition discount will be discontinued if and when you (the employee) are no longer employed with your designated law enforcement agency.
- This tuition discount only applies to core courses; general education courses are not covered by discount.
