We welcome abstracts for a poster or podium presentation from practicing nurses, advance practice nurses, and alumni on innovative and practical ideas in clinical practice, research, education, and administration that can be used in a variety of settings to include primary care, hospital, community clinic, school-based clinic, home, military, and healthcare industry. Abstracts for podium presentation must be research-focused and related to the conference theme.

Submission Guidelines

Please include the following information:

- **Presenter Information**

- Name and e-mail for each presenter
- Current employment and position
- Member of STTI? If yes, please identify the Chapter

- **Poster presentation**

- Three types of posters can be submitted: Research, Innovative Practice, and Web of Knowledge/Literature Review
- Instructions for poster content and judging criteria are attached

- **Abstracts content**

Abstracts should fit on one (1) page, one-inch margins on all sides, single-spaced with approximately 300 words. Please use Times New Roman 12-point font. We recommend a structured format with the following headings:

- Background
- Purpose
- Conceptual or Theoretical framework clearly described (for research abstracts)
- Methods
- Results
- Conclusions/Implications

Headings: Left justify and bold all headings.

If the research or project was supported in full or part by a grant, cite the grant number and granting organization at the bottom of the abstract.

Your abstract must be clean and error-free.

1. Overall Appearance
2. Content

Criteria for Poster Judging

Overall appearance (all categories)

- Poster attracts and hold viewer's attention
- Poster appears free of unnecessary detail
- Appropriate use of white space to avoid crowding
- Print visible from 4 to 5 feet
- Poster free of spelling/grammatical errors
- Content logically organized
- Content clearly written/easy to understand

Content

1. Research Poster

- Problem/background clearly stated
- Purpose/aim of the study clearly stated
- Sample or population clearly identified
- Research design described
- Variables investigated and instruments (if quantitative) clearly identified
- Data analysis procedures described
- Major findings, conclusions, and recommendations summarized succinctly for completed research
- Implications/significance for nursing described

2. Innovative Practice Poster

- Problem/background clearly stated
- Purpose/aim of the project clearly stated
- Target population to be affected described
- Implementation process clearly described
- Resulting change summarized succinctly for completed innovations
- Implications/significance for nursing described

3. Web of Knowledge/Literature Review Poster

- Topic of interest or problem statement clearly stated
- Articles current and relevant
- The information gathered synthesized and evaluated
- The key findings identified
- Implications/significance for nursing described
