- Student's Bank Statement(s). This bank statement must demonstrate that you can cover at least two years of your pledged amount noted above as student cash, checking, savings, and investments. The transaction history should not exceed three months.
- Sponsor's Letter of Intent (if applicable). This letter is written by your sponsor indicating the amount they pledge towards your educational costs and includes their contact information.
- Sponsor's Bank Statement(s). This bank statement must demonstrate that your sponsor can cover at least two years of their pledge amount towards your educational costs. The transaction history should not exceed three months.
