- **Enrollment Requirements:** Eligibility criteria for most types of aid require that you are enrolled at least half time. - **Enrollment Requirements (continued):** Aid will not be disbursed to your account unless the number of units and sessions you are enrolled in matches the enrollment status your aid is based on. Failure to enroll in all units within the term or failure to notify your Student Account Counselor of any changes may result in a delay, a revision to your financial aid, or an owing account balance. Notify your Student Account Counselor immediately if your enrollment for the academic year will not match this offer.
- **Federal Work Study:** Azusa Pacific University does not automatically package graduate and professional students with federal work-study aid, as graduate and professional programs are generally geared towards working professionals. However, if you are interested in federal work-study, please contact your Student Account Counselor for details.
- **Cal Grant:** Cal Grant funding is limited to four academic years for a student working on their bachelor degree. In order to graduate in four years, you must complete 15 units or more per semester. If applicable, students have the right to request in writing their Cal Grant B Access funds be refunded to them, excluding it from paying the outstanding balance on their student account.
