HONOR SOCIETY OF NURSING, SIGMA THETA TAU INTERNATIONAL 39TH BIENNIAL CONVENTION

Delegate Report from Viann Duncan

As your representative to the 39th Biennial convention I am reporting on my experience in hopes of encouraging each of you to consider attending this convention in the future. I left Burbank airport at about 11pm on Friday Nov. 3rd and arrived in Baltimore, Maryland about 6 o'clock the next morning. I stayed with our president Marilyn Klakovich at the Marriott Inner Harbor, within a block and a half of the Baltimore Convention Center where the Biennial Convention was held. The weather was wet and cold but there was no snow and there was not enough rain to carry an umbrella.

The opening plenary presentation was held in the grand ballroom where the décor was beautiful. The speaker, Anne Ryder, was inspirational. Though not a nurse, she is a national award winning news anchor and TV reporter, columnist and speaker. She spoke on Power, Peace and Perseverance: Lessons Learned from Mother Teresa, sharing from her heart how Mother Teresa and nurses had made a difference in her life. There were other plenary speakers over the several days of the conference and each one was inspirational and informative.

The one thing with which I was most impressed was the quality of the information shared at the convention. Each day there were opportunities to go to clinical sessions to learn what other nurses in other parts of the country and world were doing in various areas of research. I attended sessions on education strategies for success: Prediction NCLEX-RN Success: Do Results Hold Up? and Outcomes of Neonatal Education Consortium: A Tri-State Collaborative Education Model for NNPs. I also learned about Psychiatric/Mental Models and Strategies: Self-Reported Needs for Care of Outpatients with a Bipolar Disorder in the Netherlands from international members from the Netherlands, Transcultural Nursing Strategies: Humor in Healthcare Messaging: Audionovela Style and many other very interesting sessions.

On the final day I attended the House of Delegates Session - the business meeting of the Society. This was the session where debates and the vote regarding By-Law changes were held. We also held elections of International officers and accepted petitions for new Chapters. The best part of the House of Delegates Session was the installation of Carol Huston as the new president followed by her call to action.

I am very proud to be a member of Iota Sigma Chapter and would love to talk to you more about my experience. Please encourage your nursing friends to consider this organization as a worthy professional group that desires to develop leaders, serve the nursing profession and improve patient care at the bedside and in the world.

My experience at the 2007 Biennial Convention was a bit different than my 2005 experience. Although I was a delegate at both conventions, this year, I was running for a position on the STTI Board of Directors. I was unsuccessful in my bid for office, but I did learn a lot from the experience.

Because I was a candidate, I needed to attend many special forums provided for delegates to hear from the candidates and ask us questions. These were both challenging and stimulating sessions since the delegates asked many insightful questions.

I also attended many of the special events: Nancy Dickenson-Hazard's retirement dinner, the Heritage dinner recognizing members and non-members for their contributions to health care, and best of all, the Chapter Awards Luncheon. Iota Sigma was recognized for a second time with the Chapter Key Award. This award is presented to chapters who demonstrate excellence in membership involvement, leadership development, and chapter outreach. Only about 10% of the chapters qualify for this award at each biennial convention, so Viann and I were proud to represent our chapter and accept the award on the chapter's behalf.

THE SIGMA THETA TAU CONVENTION: MY POINT OF VIEW BY: JAVIER GUERRA, STUDENT LEADERSHIP INTERN

For my first time flying it was sure one of those interesting experiences, especially being seated next to complete strangers for a somewhat uncomfortable red-eye flight. Being tired because it was otherwise my normal sleeping time, I actually enjoyed the flight very much since I got a window seat on each flight with the window shades open completely, sailing like a boat through water, except it was on the air and below were not sparkles and halos of stars from the sky, but were the lights and cities. I fell asleep staring down at incredible patterns of streetlights and building lights and woke up seeing golden veins of rivers and streams reflecting brightly from the sunrise coming up over the Atlantic Ocean. A cold, beautiful city, that you could walk past 200 years of American History in a span of eight to ten blocks down Charles Street with an ethnic variety of food, beautiful lofty buildings, and monuments. Getting lost (intentionally) on my fist day out after arriving I saw an apparent socioeconomic disparity similar to my impression of the several African-American communities I had walked through near downtown of Los Angeles city. The plane did not only take me the span of America, but provided me with a wider glimpse than I had before of the span of its beauty, its potential, and the unique and similar health needs of people. The Biennial Convention amplified this concept by providing a venue in which the cares and concerns of nurses from around the world were shared and honored.

My first experience at convention was at the Speed Connect meeting in which new members of STTI were provided lunch and a fun time of connecting with many leaders and its newest members. Carol Huston, Carol Picard, and others participated in a series of ice breakers and made themselves readily available for a time to engage us, where we individually are in nursing and where we see ourselves going.

The first plenary speaker Anne Ryder, while addressing her interview with Mother Teresa, and life lessons learned through working with her ministry to the poor, presented a patient's perspective of receiving nursing care and the impact on her life it has had, especially when she went through obstetrical complications with her pregnancy. Her speech was very reaffirming to the call a person has to provide nursing care, and that nursing care is needed across the globe. She presented her belief that the spirit is one of the most underserved parts of human beings, but that while nursing offers this kind of care, nurses need to be mindful of their own spiritual needs.

The second plenary speaker, Dr. Loretta Sweet Jemmott, addressed how persistence in the profession to advocate on behalf of the patient through research dissemination, whether for individuals or even nations, is necessary in order to provide optimal health and disease prevention. Also, she described that the need to translate this advocacy and research creatively across cultures is one need nursing must improve upon.

The third plenary speaker, Dr. Silvina Milvarez, spoke one of the most significant statements that I remember: "Health is a bridge to peace." This is a concept with a world wide impact that, while war, disaster, disease, and suffering prevail in many regions of the world, nursing care is continually needed in these regions. Our ability to extend our knowledge, support, resources, and able bodies as an international community provides a most agreeable olive branch to those whose health is positively affected by nursing, essentially, encouraging a form of international healthcare diplomacy by entering into collaborative endeavors to achieve global health goals.

In the concurrent sessions I gave preference to sessions focused on gerontology, evidence based practice implementation, and nursing education innovations. I have more notes from those sessions than I know what to do with. Really, this was a great opportunity to gain an overview of what research and innovations nurses focus their efforts towards. It was very special to see Dr. Patricia Hanes present the development of the Combat Readiness instrument for the U.S. military, to have Dr. Marilyn Klakovich run for an elected position, and to take a seat along side Viann Duncan at both the plenary sessions and for dinner. In all of my meetings with members from other chapters it was apparent that very few had registered nurse students in attendance, let alone had sent students to the convention with some sort of financial support. Several faculty members I spoke with plan to imitate our chapter in supporting students to attend in the future. The convention, being in Baltimore, also allowed for me to attend the National Evaluation Association conference to present with Dr. Connie Brehm and Dr. Martha Ann Carey. In our presentation, Enhancement through Integration of Assessment and Accreditation, we presented our findings from our own school's accreditation review and review of professional evaluation literature and professional assessment literature.

I appreciated that there was a central focus of developing and using research for improving healthcare across all settings where nursing assistance is needed. With the continuing internationalization of nursing research, I was so impressed with meeting many people from different countries able to carry on a conversation about their patients, or about their research focus, and how the conversational translation was facilitated by the common language of nursing. It was exciting to see this large amassing of healthcare professionals addressing together the health needs of people globally through nursing research and practice and continuing the advancement of the profession through service, education, collaboration, and international relationships, which are all goals that Iota Sigma is pursuing.





2007 HOUSE OF DELEGATES REPORT: BYLAWS AMENDED BY VIANN DUNCAN

Thank you for allowing me to represent you as a delegate, along with Marilyn Klakovich, at the 2007 House of Delegates held at the end of the Biennium Convention last November. I enjoyed the experience and want to encourage each of you to consider being a delegate when the opportunity presents itself. The House of Delegates is the formal business meeting where new officers are elected and the international bylaws are amended. Before Marilyn and I left for the convention, members of Iota Sigma had given us instructions on how to cast our votes for you. I am including the changes to the international bylaws that were discussed and passed. I will give you the highlights as I saw them. There were 22 proposed changes - 21 passed by the House of Delegates.

- 1. Remove specific words about kind of person that qualifies. Now states that Sigma Theta Tau International does not discriminate. Candidates are qualified for membership so long as eligibility requirements are met.
- 2 & 4. Academic Achievement removed the 3.0 GPA for basic nursing program. Now states: Students in basic program shall be eligible for membership if they have achieved excellence according to the standards approved by the society. The guidelines will explain the GPA requirements for all levels of students.
- 3. Rank in class this change did not pass. It will remain the highest 35% of the class in scholarship.
- 5. Addition of statement that students could be considered a candidate for membership in another chapter if the institution that the student attends doesn't have a chapter.
- 6. Includes statement that "Members may also formally request to discontinue membership."
- 7. Members may be active in more then one chapter
- 8. Honorary members may be inducted in locations and times decided upon by international board of directors.
- 9. Revocation of Membership May be revoked at any time by a chapter to which the member belongs for just cause and after due process.

Changes 10 -15 were all related to the Chapter business. The organization of a chapter, the chapter officers, chapter meetings regarding business meetings and scholarship offerings, chapter responsibilities and what happens to the money when a chapter dissolves.

Changes 16 and 17 had to do with terms that international officers may hold and committee membership.

Changes 18 - 21 were under the finance section and related to when dues would be collected for new chapters. Several other sections were removed.

Change 22 had to do with parliamentary authority. International will use the current edition of Robert's Rules of Order Newly Revised.

The Iota Sigma chapter of The Honor Society of Nursing, Sigma Theta Tau International, Inc. invites you to submit a proposal for a student poster presentation competition for the 4th Annual Research Day, cosponsored by the Azusa Pacific University School of Nursing and Iota Sigma. Health disparities is the focus of the Research Day and the goals are:

- Provide an avenue for dissemination of evidence-based research and linkages to clinical applications.
- Utilize researchers as role models to encourage excellence in students and colleagues.
- Provide networking opportunities and promote collegiality among students and nursing professionals.

We welcome poster proposals from undergraduate and graduate student nurses on innovative, practical ideas in administration, clinical practice, research, and education that can be used in a variety of settings including ambulatory, hospital, home, school, military, and industry. Posters do not need to relate to the conference theme, but must be based on scholarly work. Individual or groups of students can submit a poster. Posters presented at other conferences can be submitted, as long as they have not been presented at a previous APU/SON Research Day. The Iota Sigma research committee will provide assistance and resources to undergraduate students for poster preparation.

The Iota Sigma Research Committee will judge the posters based on the following criteria:

- Clarity of description of the content
- Importance, depth, focus, level of audience interest
- Feasibility of application to a variety of settings
- Originality of topic/presentation
- Overall appearance of poster

In recognition of Iota Sigma's 20th anniversary as a chapter, the winning poster in each of the following categories will receive an award of \$200:

- 1. Undergraduate student poster
- 2. Graduate student poster (MSN or PhD)

RESEARCH AWARD

PURPOSE OF THE AWARD

Iota Sigma chapter has allocated monies to provide assistance to members who are conducting investigations on phenomena relevant to nursing.

CRITERIA FOR AWARDING GRANTS

- 1. Applicants are required to meet the following criteria*:
 - 1. Are registered nurses with current license.
 - 2. Are ready to start or have started the research project.
 - 3. Have submitted a complete research application.
 - 4. Have signed research agreement with Iota Sigma (see Research Grant Application Form).
- 2. The grant award will be based on the quality of the proposed research, the past performance and future promise of the applicant, and the applicant's research budget.
- 3. The Research Committee of Iota Sigma will recommend who will receive the grant award

GRANT ALLOCATION

- 1. Proposals should include a complete project budget specifying how the designated \$750 award will be allocated.
- 2. Duplicate funding is not permitted; however, dual or multiple sources of funding to make a larger study possible is permitted.
- 3. The Research committee will consist of 3 voting members. They are the Research Chair of Iota Sigma and 2 active members who have earned doctorates and have had experience in research.
- 4. Policies and procedures used in making the award are approved by the Iota Sigma Board Members.
- 5. A proposed deadline is on February 28 each year.

GENERAL INSTRUCTIONS FOR APPLICANT

- 1. Send applications to the Iota Sigma Research Chair on or before February 28 each year.
- 2. Submit 3 copies with the following subsections: (1) Application form, (2) Proposal narrative & (3) Appendices (or submit electronically to mklakovich@apu.edu)
- 3. A final report is to be submitted to the Iota Sigma Research chair within 3 months after completion of the study. Theses or dissertations are not acceptable as final reports.

 (See guidelines for Preparation of the Final Report.)
- 4. Awardee is required to present the completed study at the next Southern California Joint Research Conference following completion of the study.

- 2. Purpose/Aims of Study: Clearly state what the study is intended to accomplish and/or what research questions are to be answered and/or what hypothesis(es) is (are) to be tested.
- 3. Significance of the Study: What is the potential contribution of your study to nursing?
- 4. Research Design and Methods: Identify the research design.
 - 1. Subjects: Describe the target population and characteristics of the subjects. Include tnumber of subjects, the rationale for sample size, the sampling frame and the sampling procedure.
 - 2. Instruments: Reports the specific characteristics of the instruments, including the psychometric properties (reliability and validity). Address how the tool will be used. Include the measure in the Appendix.
 - 3. Procedures: Describe clearly the procedures for data collection. Specify what kinds of data you expect to obtain. Provide study protocol if interventions are involved.
 - 4. Data Analysis: Describe the means by which the data will be analyzed and/or interpreted.
 - 5. Time-Frame: Provide a 12-month schedule that details the timing of the main steps of the study.
- 5. Human Subjects or Animal Use: Include a copy of the IRB approval of the sites where data collection will take place and a copy of the consent form in the appendix.
- 6. References: List the references cited in the proposal using APA format.
- 7. Appendices (include only if applicable):
 - 1. Letters of support from thesis/dissertation advisor, co-investigator(s), and consultant(s)
 - 2. Resume or CV of principal investigator.
 - 3. IRB approval form (if human subjects or animal use involved).
 - 4. Consent form
 - 5. Copy of paper/pencil instrument, interview format or other instruments, scoring instructions and documentation of copyright permission when appropriate.

GUIDELINES FOR PREPARATION OF THE FINAL REPORT FOR FUNDED PROJECTS

Final narrative and financial reports are due 90 days following completion of the funded project. The final report should consist of a 200 word abstract which summarizes project aims, study findings and recommendations. A report reflecting actual expenditures should be attached.
