

## The Quest **Uniform Guidance Series: Part II**

Indeed, implementing revised federal regulations for managing grants, otherwise known as Uniform Guidance (UG), has been a quest at APU. An earlier Cornerstone article titled "The Quest. Uniform Guidance Series: Part I" gave an overview anticipating UG. Since then, federal agencies continue to clarify UG requirements even as UG is being rolled out. The APU ORG site has resources and links to help researchers and research administrators navigate these new regulations. Here are a few questions:

#### What is subject to this new guidance?

The Uniform Guidance applies to new federal awards and most noncompeting federal renewals starting with July 1, 2015. As a point of clarification, APU will apply one set of internal policies and procedures for all grants.

What changed in the APU grants policy and procedures?

The APU Grants Handbook was restructured during spring 2015 to specify sub-recipient requirements and to provide updates on cost principles and grant administration. You will find the new Grants Handbook at http://www.apu.edu/researchandgrants/grants. The APU Business Office also updated its grants policies and procedures. Property and inventory procedures, internal controls, purchasing, and travel are now aligned with federal regulations.

#### How does UG impact grant proposal preparation and routing?

Federal funding opportunities announcements (FOAs) are now required to include information on the review criteria. Also, UG requires federal agencies to announce FOAs at least 60 days prior to the deadline. As far as internal APU routing is concerned, applications that include sub-recipients will go through more thorough analysis than others. (Article continued on Page 4)

...undergraduate research at APU has been. I had the opportunity to join a research team during my sophomore year. Dr. Prosser, assistant professor in the Department of Biology and Chemistry, was willing to take me on as a student researcher for her project in adoptive immunotherapy. We had been

working to develop different genetic engineering platforms that provide immune cell stimulation and an increased ability to recognize and destroy cancerous cells. I learned how to be better at thinking critically and analyzing different pieces of information. While doing summer research, the techniques and, more importantly, the purpose of the methodology became clear. Performing the techniques at the lab bench allowed for a clearer and more thorough understanding of the concepts that I had learned in the classroom. I believe that comprehending both aspects of the process, the practical techniques as well as the theoretical components, is crucial. My understanding was enhanced when in Fall 2014, I had opportunities to present a research poster at the Department of Biology and Chemistry's Fall Research Day and at the Southern California Conference for Undergraduate Research (SCCUR) held at CSU Fullerton. Both of these opportunities increased my knowledge of the project and my confidence in presenting and explaining complex research. In addition, I had the opportunity to participate in a W. M. Keck Foundation site visit as a part of the Undergraduate Education Program Grant review process. This allowed me to observe what is involved in pursuing external

grants and to see APU's vision in expanding its biology program. I am so thankful for APU, specifically Dr. Prosser, for providing these opportunities which have prepared me so well for the future.

## **Faculty Spotlight**

.... APU Masters Social Work (MSW) students at the Los Angeles County Department of Children and Family Services (DCFS). The UCLA grant is sourced through a larger grant provided by Los Angeles County. Dr. Rawlings' project titled "*Master of Social Work* 



*Child Welfare Training Grant*" was recently renewed and funding during 2015-16 amounts to \$248,432. This will support seven MSW intern stipends and a part-time faculty position that provides training and liaisons with agency field instructors and DCFS. Participation in this project will allow the APU MSW program to recruit and prepare students for employment in DCFS upon graduation, thus supporting DCFS workforce goals of developing professionally trained social workers. This project has gone beyond providing excellent opportunities to advance APU students and the APU MSW program. It has also created avenues for APU to participate in the University Consortium for Children and Families (UCCF) with other Los Angeles County MSW programs, including those housed at the University of Southern California, local California State University campuses, and Los Angeles County agency partners such as the Department of Mental Health. Indeed, Dr. Rawlings is enthusiastic about APU's participation in developing and advancing new paradigms for the effective training and preparation of a social work workforce in Los Angeles County.

Earlier this year, Dr. Rawlings partnered with Dr. Rachel Castaneda, APU BAS Department of Psychology, as a co-investigator in a multidisciplinary grant application to the U.S. Substance Abuse and Mental Health Administration (SAMHSA). During summer 2015, SAMHSA announced this project titled "*SBIRT Training Initiative among Allied Health Professional Disciplines at Faith Based Universities*" would be funded at \$935,831. The project seeks to creatively enhance the curriculum of psychology, nursing, and social work disciplines within faith-based universities in order to equip professional students with skills to implement evidence-based SBIRT strategies for patients at risk for substance use disorders.

In a recent ORG faculty panel, Dr. Rawlings emphasized the importance of having professional mentoring relationships. She described how she had unique opportunities to advance her professional research and scholarship skills under the tutelage of an experienced mentoring scholar.

Dr. Rawling's practice interests are in women's issues and mental health. She conducts research in developing observed structured clinical exams for evaluation of social work skills. She is keen to develop competency-based education and to help students develop skills necessary for entry-level practice. Dr. Rawlings is also highly interested in assessing outcomes of social work education and exploring experiential learning models such as service-learning that can enhance student educational outcomes.

On a personal note, Dr. Rawlings is currently learning to play golf and loving it! She also loves to travel and just spent time this summer in Egypt, Jordan, and Israel.

#### (The Quest, continued)

... This does not, however, affect APU's internal routing timeline. APU's routing deadlines continue to be 10 business days prior to submission deadlines.

#### How does UG impact grant administration?

Besides observing cost principles and post-award and audit requirements, grant administration is especially impacted when awards include sub-recipients. Increased responsibility is assigned to the primary institution (aka: pass-through entity) creating the need for enhanced sub-recipient monitoring. In addition, new regulations require the final closeout be done within 60 days of the project termination. This timeline could create pressure for sub-recipients to expedite their submission of final invoices. Finally, there are new emphases on sharing excess equipment and supplies and on having consistent internal controls.

#### What else should researchers be aware of?





#### Certificate of Achievement in Grants Training
